5. Sealed or electronic bids must be submitted to the office Chautara Sangachowkgadhi Municipality, Chautara, Sindhupalchowk by hand/courier or through PPMO website www.bolpatra.gov.np/egg on or before as mentioned above. Bids received after this deadline will be rejected.
6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 4,87,100.00 which shall be valid for 30 days beyond the validity period of the bid .
7. Bids shall be opened in the presence of Bidders' representatives who choose to attend at above mentioned date and time at the office of Chautara Sangachokgadhi Municipality.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
