- 5. Quotations must be valid for a period of 45 days after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above, which shall be valid for 75 days after opening of the Sealed Quotations.

If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Khata No. 057030000000000387 of Chautara Sangachokgadhi Municipality Office, Chautara, Sindhupalchok in the Office Code No. 23-365-14 of Nepal Bank Limited, Sindhupalchok Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
